The Buyer's Responsibility:

The buyer must have the puppy examined by a licensed veterinarian within 72 hours after delivery. The seller must be notified of the examination results immediately by email or snail mail. The failure to comply will result in the immediate cancellation of this guarantee.

The buyer must provide the puppy with routine preventive care such as, but not limited to the following: *Annual physical examination by a licensed veterinarian. *Annual vaccinations and de-worming as recommended by a veterinarian. The puppy must be paid for in full by seven weeks of age or all monies paid and all claims to the puppy will be forfeited. Puppies must be neutered/spayed before first heat cycle. All deposits are NON-REFUNDABLE.

Health Guarantee:

The afore listed puppy is guaranteed until one year of age against fatal and life altering congenital diseases which adversely affects the health of the animal. This includes severe hip dysplasia which hampers the dogs movement and natural gait and which requires surgery to correct, kidney, heart, pancreas, spine and liver problems of a severe, life threatening or altering nature. If the dog dies within this one year time frame, the buyer must pay to have the animal autopsied to determine the reason. If the reason is found to be congenital, the Seller will replace the puppy. This guarantee does not cover what in the some breeds are considered normal, such as: Brachycephalic Syndrome, Cherry Eye, Entropion, Loose Hips, Skin Allergies, Elongated Soft Palate, and Stenotic Nares (Collapsed Nostrils). All puppies covered under this guarantee are for replacement only. We DO NOT issue refunds for any reason.

The Seller will not be responsible for any medical expenses incurred. The buyer is aware that owning a puppy means providing trips to the veterinarian and understands he/she will be responsible for all payments. As of the date of delivery, the puppy has received the proper vaccinations and de-worming is at the proper times. The Buyer has been informed of this and of future vaccinations and de-worming is due. This guarantee does not include Coccidia and Kennel Cough, which is common in puppies that are shipped and usually caused by bacteria. Kennel Cough is self limiting and like the common cold, it must run its course. Full recovery can be expected and Kennel Cough on its own is not a life threatening ailment.

A puppy showing serious genetic or congenital defect will be replaced as follows: The animal must exhibit the defect by one year of age. The Seller must be notified of the problem within two business days of the licensed veterinarian's determination and have two reports from two unassociated veterinarians stating the same problem and the Seller will provide a

replacement puppy of equivalent value. A puppy with a defect must be returned or euthanized with the prior permission of the Seller to qualify for a replacement puppy. No refund, in full or in part, will be given under any circumstances. A returned puppy must be returned to the Seller in good condition, other than the specified problem, at the Buyers expense. The Owner will then qualify for a replacement puppy. The Buyer is responsible for transportation costs to and from the Seller for the replacement puppy. This guarantee applies to the original puppy only and is nontransferable to a second party.

No replacement puppy will be given if the puppy has been bred, or euthanized without the Sellers permission. The replacement puppy will be one mutually agreed upon by both parties and will be of comparable quality. It is understood that the replacement puppy may not be from the exact same parents of the original puppy. There are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders that are not covered by this guarantee. Any physical problems which are or could be the result of injury is not covered under this guarantee. There is no guarantee or warranty that the Buyer will be able to show or breed the puppy regardless of show or breeding potential exhibited as a puppy. This contract supersedes all previous agreements. This contract is null and void if the terms and conditions are not fulfilled. The Buyer agrees that he/she understands this contract fully.

If you purchase a puppy at a discounted rate then you will be credited the amount you paid for the puppy to put towards the purchase of your replacement puppy. An example: if you paid \$1000.00 for a puppy that was marked down for whatever reason you will have \$1000.00 towards another puppy.

Shipping / Delivery:

The puppy will be shipped between eight and ten weeks of age with most being shipped at eight but some needing time to mature and will be shipped at a later date.

Sellers Disclaimer:

As Seller is only guaranteeing above puppy as healthy companion pet and that the puppy's pedigree is correct to the best of the Seller's Knowledge, Buyer agrees not to hold Seller responsible (except for congenital / genetic defects guaranteed covered as detailed above) in any manner in the unlikely event that a problem might arise from puppy's pedigree/parentage.

The contract will be sent with the puppy. If it is not signed and returned within two weeks there will not be a health guarantee on your puppy.

THIS CONTRACT WILL BE NULL AND VOID IF IT DOES NOT CONTAIN BOTH BUYER AND SELLER SIGNATURES.
